### 85. CHAIRMAN'S ANNOUNCEMENTS

Incidents of dog fouling are still occurring in Bothel. Cllr Mounsey had provided the Parish Council with some additional signage and the Street Scene Officer at the Borough Council had been requested to reapply the stencils on the pavements.

The Parish Council had been approached by a member of the public with regard to the Greyhound public house being on the market again and if anything could be done to prevent development of the site. The Parish Council have contacted Allerdale Borough Council for more information on this.

### 89. REPORTS

(a) Allerdale Borough Councillor: Cllr Mounsey reported that at the last full Council meeting it had been agreed to increase Allerdale's portion of the council tax by £5.00 a year on a band D property. At the same meeting the councillors' allowances had been increased by £100. Cllr Mounsey also reported that the Borough Council are to pilot a digital transformation programme.

# 94. HIGHWAYS/HIGHWAY MAINTENANCE

The Chairman reported that he had contacted David Bell from Cumbria Highways regarding the drainage issues on the A595.

Members noted that the repairs required on the Bothel to Threapland road will not be carried out until United Utilities have completed their work in this area.

The consultation regarding the major road networks had been circulated. Members agreed to respond to the consultation in support of the proposal that the A596 as opposed to the A595 be designated as the major road network to West Cumbria.

#### 95. GRASS CUTTING CONTRACT 2018

The Clerk reported that three contractors had submitted tenders for the grass cutting contract for 2018. The tenders were considered at the meeting. The comments from two contractors that eight cuts were considered unrealistic were noted by members.

RESOLVED that:

the tender from Messrs Hunt be accepted for the grass cutting at Threapland at £90 cut;

the tender from I Steel be accepted at £65.00 per cut for Pinfold Green, £30.00 per cut for Broadwell Green, Bothel Village Hall Outside £25.00 per cut and Bothel Village Hall Inside £30.00 per cut. The respective contractors to be notified accordingly.

### 96. DONATION REQUEST

The request received from Cumbria Children's Dyslexia Project was considered. RESOLVED that £200.00 be granted from the Community Fund.

### 97. PINFOLD GREEN

Members noted that the application to register Pinfold Green as a Village Green had been acknowledged by Cumbria County Council Commons Registration. Once checks with local and national planning authorities have been carried out Commons Registration will advise whether the application can be accepted for processing.

## 98. UNITED UTILITIES LEGACY FUND

Notification had been received that the Legacy Fund was now open for applications. Members noted that an application had been submitted from Bothel First Responders for a public access defibrillator to be installed in the telephone box in Bothel and the Village Hall Committee are in the process of preparing an application.

## 99. VILLAGE HALL

Cllr Watson reported that the renewal for the Village Hall insurance had been received. Members were asked to consider paying a contribution towards the annual cost. RESOLVED that £470.00 be paid from the Community Fund towards the insurance costs.
